

# KKF Board Report 2019

The following will be a Founders Report of 2020 activities and the status of the foundation ...

### ACTIVITIES

As presented in the attached pages, the Keenan's Kids Foundation (KKF) has essentially four activities:

- 1. Service projects, which range from the clothing drive for homeless kids to the sandwich making for children's centers and the personal care product drive.
- 2. We currently have nine safety programs, however not all nine are done each year, we rotate. During 2019 we completed playground safety, Fourth of July safety and toy safety programs.
- 3. We continue the longstanding law student closing argument for children competition. The most recent event concluded on 09 Feb. 2019. All 2020 activities were cancelled because of COVID19.
- 4. The Murphy House project is by far the most expensive and time-consuming project we have.

### **FUNDING**

## **THE FUTURE**

#### Law Student Closing Argument Competition

After 22 years of our law student competition in Georgia, we are expanding into Florida where we hope to offer a competition at least in North Florida that is north of Orlando or the entire state.

#### Recreational Center for At Risk Youth

Now that our founder Don Keenan is spending a majority of time in North Florida with a KKF office near by, we have decided to take on a major project centered around a youth center. We've surveyed both the community attitude as well as existing programs for over a year and have confirmed a direct need for a youth center which is nonprofit. The two centers that do exist charge for admission which according to many parents, disqualifies their child from taking advantage of the services.

We have been searching in earnest for either a location upon which we can build or a lease property. We are within go days of securing an appropriate place.

The plans for what type of activities will be available are still ongoing. First, we have had donated an entire, fullyequipped commercial gym that will surely be a part of the program offered. In addition, we are considering a computer lab, a dance floor, an actual vegetable garden which the kids will learn how to plant and cultivate.

These are exciting times and we believe that our cautious planning will pay off.

Our foundation web site is over 10 years old and in drastic need of overhaul. We are pleased to announce that Shawn Grant with Accelerate Now has graciously agreed to do the upgrades which should be completed by the middle of June.

## **Keenan Trial Institute**

We are in the transition of shifting our focus to the Keenan Trial Institute (KTI). There are currently 21 undergraduate and graduate level courses being offered as continuing education that serve 5,480 students. There are 1,243 undergraduate and 169 graduates.

We hope for the continued income stream from the Keenan Trial Institute whose profits fund the Keenan's Kids Foundation.

We continue to host seminars of varying topics which also now fall under the responsibility of KTI.

In March, we thought the Institute was over and that seminars would never occur as the virus spread. Fortunately, we were wrong and quickly offered a virtual alternative. Surprisingly, the seminar attendance and the Institute attendance has skyrocketed. Necessity is the mother of all invention.

As techniques evolve, we look to add more courses and seminars.

## **Clothing Drive**



Even before the official start of KKF, in 1993, the children's clothing drive was on going.

During Hurricane Katrina relief efforts, KKF was the second largest supplier of children's clothes to relocated families in Atlanta.

As of 2020, KKF obtained and distributed 24,747 items of children's clothing to homeless shelters, group homes, and children's hospital emergency rooms.



### Sandwiches



Began before the start up date of KKF we made between 200-300 baloney and cheese sandwiches a week to distribute to homeless shelters (now the more healthy turkey and cheese).

Since the beginning we've made and delivered more than 570,000 sandwiches.

### **Personal Care Products**





Commencing in 2005, traveling members of the law firm and KKF bring back the small containers of person care products not used during their stay. These items include soap, shampoo and conditioner.

We then sort these items into small kits to make complete personal hygiene packages.


These packages are then delivered to homeless shelters that service children.

# Murphy House Project

## **Murphy House Project**

Current Status of Loan Fidelity Bank Principal Balance a/o 9.3.19: \$301,583.40 Update for 12Jun2020: \$290,050.77 The maturity date of the loan is 7.15.2022


At the last loan renewal/modification in July of 2017, a \$50,000 principal reduction was made bringing the balance to \$330,994.01.

Since that time the note is being paid down by monthly principal and interest payments in the amount of \$2,770 at an interest rate of 6.0%. It is expected that another \$50,000 principal reduction will be required to renew the loan at maturity in July 2022.


The loan is in the name of KKF. The bank considers this a "commercial loan" (as opposed to a personal mortgage) thus the higher than normal mortgage interest rate and shorter than typical maturity. As a typical mortgage would be structured with an amortization of 15 or 30 years and a more favorable interest rate.

My recommendation at this time would be for KKF to maintain a mission and a service footprint in both Atlanta and SRB to benefit from the non profit status in both states. The upcoming horse ranch project would establish a mission in Florida and we will plan to apply for 501(c)3 status once this mission is established.

With the hiring of an experienced Videographer, TB teaming up with NJ, there is great potential to increase the visibility of the mission of KKF. Both the Atlanta Murphy Home Project and the upcoming SRB Horse Ranch Project are exciting and needed services to these communities. I would love to see these missions come to life online and throughout our other marketing platforms in the coming year.

### Santa Rosa Beach Office


